On August 9, 2000, the State of Wisconsin Pharmacy Examining Board reviewed supporting documentation submitted on behalf of Mr. Pampuch for an order granting a stay of suspension pursuant to the *Final Decision and Order* in the above-captioned matter entered on March 10, 1999.

Based upon the foregoing,

IT IS HEREBY ORDERED that Kevin Pampuch be granted a one month stay of suspension.

FURTHERMORE, IT IS ORDERED that Mr. Pampuch appear with his therapist, Lila Cunningham, at the next meeting of the board scheduled for September 12, 2000.

FURTHERMORE, Mr. Pampuch and his therapist, Lila Cunningham, are directed to familiarize themselves and immediately come into compliance with the following:

- 1. Drug Screening required by paragraph 2 b (4) of the *Final Decision and Order* shall be RANDOM, not clustered at any set time at the end of the month, and shall be NOT LATER than 5 hours following a request for a specimen.
- 2. As per the board's previous order of May, 2000, the required number of drug screens is EIGHT (8) PER MONTH.
