ORDER GRANTING FULL LICENSURE
On September 17, 1999, the Board of Nursing issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent's license to practice as a registered nurse in Wisconsin was limited to require in part that within 90 days she submit evidence of conducting a nursing staff in-service on the subject of the importance of maintaining current licensure. On January 6, 2000, the board considered evidence of Ms. Brandstrom's full compliance with the terms of her limited license. Accordingly, the board orders as follows:
<u>ORDER</u>
NOW, THEREFORE, IT IS ORDERED that all limitations on the license of Ann M. Brandstrom, R.N., to practice professional nursing in the State of Wisconsin, as imposed by the board's Final Decision and Order in this matter dated September 17, 1999, be, and hereby are, terminated, and Ms. Brandstrom is hereby returned to full licensure.
