Applicant FULL LICENSURE

On or about September 18, 2000, applicant filed her application for a license to practice as a practical nurse by endorsement from Minnesota. Her application reflected that applicant is currently under an order from the State of Minnesota Board of Nursing dated October 23, 1997, by which applicant was required to receive six months of one-on one instruction from a nurse consultant on documentation and nursing skills, after which the nurse consultant was to submit a reports to the Minnesota board on applicant's progress and recommendations for improvements in her nursing skills. Applicant was also required to submit a report on what she had learned.

The board considered the application at its meeting of June 1, 2001, and noted that no evidence has been provided that applicant has fully complied with the requirements imposed by the Minnesota order, or that her license is currently unencumbered. Accordingly, Ms. Crowder was granted a limited license to practice as a practical nurse in Wisconsin, imposing the same limitations as are set forth in the "Agreement for Corrective Action" issued by the Minnesota Board of Nursing on October 23, 1997. Ms. Crowder was permitted to petition for an unlimited license at such time as she was able to submit satisfactory evidence that she has fully complied with the Minnesota Order, and that the Minnesota Board of Nursing has restored her to full licensure.

On September 6, 2001, the board considered evidence that Minnesota has reinstated Ms. Crowder's to full licensure in that state. Accordingly, it is ordered as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that all limitations on the license of Teresa D. Crowder, LPN, to practice as a practical nurse in Wisconsin are terminated, and Ms. Crowder is granted full licensure.
