ORDER ADOPTING STIPULATION

On September 11, 2000, applicant filed her application for a license to practice as a professional nurse in Wisconsin by endorsement. On her application, applicant notified the board that she had been subject to disciplinary action against her RE license on three separate occasions in other states.

The board considered the matter at its meeting of August 2, 2001, at which time applicant appeared in support of her application. The board and Ms. Beidleman thereafter entered into a Stipulation, by which the board agreed to issue and applicant agreed to accept a limited license to practice as a registered nurse in the State of Wisconsin.

Based upon that Stipulation, and other matters of record, the board orders as follows:

NOW, THEREFORE, IT IS ORDERED that Paula J. Beidleman, RN, is hereby granted a limited license to practice professional nursing in Wisconsin imposing the following terms and conditions.

(1) Applicant shall be responsible for submission to the board of twice yearly written reports prepared by her nursing employer(s) setting forth her activities and performance in her employment.

(2) Upon a showing of complete, continuous and successful compliance for a period of two years with the foregoing condition, the board shall grant a petition by applicant for a full license; provided, however, that prior to granting the petition, the board may in its discretion require that applicant comply with the foregoing condition for a period of one year while applicant is actively employed as a registered nurse.

(3) Applicant shall provide her employer and any prospective employer with a copy of the board's Order immediately upon its issuance. Should applicant change employers, a copy of the Order shall immediately be provided to the new employer.

(4) Applicant shall report to the board any change in employment status, change of address or phone number within five days of any such change.

(5) Violation of any of the terms of the limited license may result in summary suspension of the limited license, the imposition of additional conditions or limitations, or other discipline as the board may deem appropriate.
