On May 15, 2001, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Eric A. Schuster, R.Ph., for a stay of suspension of his license to practice pharmacy as provided within the board's *Final Decision and Order ("Order")* dated May 14, 1996, case number 95 PHM 55, and that he be allowed to work as a pharmacist in charge.

Based upon the board's review, the board finds that Eric A. Schuster must demonstrate to the board three months of compliance with the board's *Order* prior to petitioning for a stay of suspension under the terms of the *Order*. The handwritten list of dates titled, "durg" screens, submitted via facsimile purportedly from the Janesville Psychiatric Clinic is insufficient proof of negative urine screen testing results.

IT IS HEREBY ORDERED, that the petition of Eric A. Schuster, R.Ph., for a stay of suspension of his license to practice pharmacy and for modification of the *Order* to be allowed to work as a pharmacist in charge, is denied.
