On June 13, 2001, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the request by Mark G. Anderson, R.Ph., for a three-month extension of the stay of suspension, as provided within the board's *Final Decision and Order* dated August 9, 2000. The department monitor reported by memo dated May 8, 2001, that she spoke with the respondent's attorney, Hal Harlowe, who indicated that the respondent was terminated from his employer for drug diversion. The respondent denied taking any drugs. The department monitor reported by memo dated May 17, 2001, that she was informed by a representative of the respondent's employer that the respondent had been videotaped "taking some medications." It is currently unknown what medications were taken.

Based upon the board's review of the respondent's petition and the documents submitted, and based upon the board not receiving information from the respondent explaining or further contesting the above allegations, the board finds that the respondent has violated paragraphs 2a and 8 of the *Order*.

IT IS HEREBY ORDERED: that Mark G. Anderson, R.Ph., is denied a three-month stay of the suspension of license #9189 to practice pharmacy in the State of Wisconsin. The respondent may petition the board for a stay of suspension at the next regularly scheduled meeting of the board at which time he may explain or contest the allegations of drug diversion.

IT IS FURTHER ORDERED: that Mark G. Anderson, R.Ph, shall cause to be delivered to the board, through the department monitor, urine screens for the months of April, May and June 2001. The petition of the respondent to Modify the *Order* is DENIED as moot.
