ORDER REINSTATING THE LICENSE

Respondent

On March 3, 2000, the Examining Board of Architects, Landscape Architects, Professional Engineers, Designers and Land Surveyors issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent's license to practice as a professional engineer in Wisconsin was limited to require that he submit quarterly reports describing all engineering work performed by him in the State of Wisconsin. The Order provides that the respondent may petition for termination of the limitation any time after one year.

On July 13, 2001, the Engineer Section considered Mr. Durand's petition for termination of the limitations on his license. Based upon all information of record herein, the board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that all limitations on the license of Paul H. Durand, P.E., to practice professional engineering in the State of Wisconsin are hereby terminated, and Mr. Durand is reinstated to full licensure.
