On July 7, 2000, the Board of Nursing issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent's license to practice as a registered nurse in Wisconsin was suspended for an indefinite period, with provision for successive three-month stays of the suspension conditioned upon compliance with certain conditions and limitations on the license. Among these were that respondent participate in a recognized program for the treatment of chemical dependency, that she participate in psychotherapy a minimum of once each week, and that she participate in program of random witnessed monitoring for controlled

On November 3, 2000, March 1, 2001, and July 9, 2001, the board granted Ms. Still Church's requests for further three month stays of the suspension of her license.

substances and alcohol in her blood or urine on a frequency of not less than once per week.

On September 6, 2001, the board considered Ms. Church's request for a further stay. The board also considered evidence that Ms. Church is out of compliance with the board's July 7, 2000, Final Decision and Order, and denied the stay by its Order dated September 14, 2001.

On November 2, 2001, the board considered Ms. Church's request for reinstatement of the stay. Based upon all information of record herein, the board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a further three month stay of the suspension of the license of Mary Lou Still Church is granted, and the suspension is hereby stayed for a further period of three months.
