A Notice of Hearing and Petition for Administrative Injunction were filed in this matter on September 27, 2000, and a hearing was subsequently scheduled to be conducted on July 10, 2001. On June 14, 2001, the Administrative Law Judge received notification from Arthur Thexton, attorney with the Division of Enforcement, that Ms. Bernard has become licensed in Wisconsin. Accordingly, Mr. Thexton requested that the matter be dismissed. Based upon Ms. Bernard's having become duly licensed to practice as a pharmacist in the State of Wisconsin, the Administrative Law Judge recommends that the Department of Regulation & Licensing adopt the following Order.

NOW, THEREFORE, IT IS ORDERED that The Matter of the Petition for an Administrative Injunction Involving Stacy N. Bernard, R.Ph., be, and hereby is, dismissed.
