On October 26, 2000, the State of Wisconsin Real Estate Board issued a *Final Decision and Order*, ("*Order*") requiring, among other things, that the respondent successfully complete the business ethics module from the pre-licensing real estate broker's course as set forth in Chapter RL 25 of the Wisconsin Administrative Code, by no later than six months from the date of the *Order*.

At its meeting on June 28, 2001, the board reviewed a request from the respondent that he be granted an extension of time to obtain the required education.

Based upon the board's review of the request:

IT IS HEREBY ORDERED that the respondent is granted an extension to August 31, 2001, to complete the education required under the *Order*.
