On November 3, 2000, the board issued its Final Decision and Order in the above-captioned matter. Under the board's Order, Ms. Anderson was required to submit documentation that she had notified employers, insurance carriers and E.D.S. Federal that she had practiced for a period of time without a current registration.

On March 1, 2001, the board considered Ms. Anderson's request for reinstatement to full licensure, and further evidence that she has completed the required notifications. Accordingly, it is ordered as follows:
