On November 3, 2000, the board issued it Final Decision and Order in the above-captioned matter. Under the terms of the board's Order, Ms. Grothe was required to notify affected parties of the fact that she had practiced for some period of time without a current registration.

On February 2, 2001, the board considered Ms. Grothe's petition to grant a return to full licensure based upon the fact that she had complied with the terms of the board's Order. Based upon that petition, and upon all other information submitted, the board orders as follows:

NOW, THEREFORE, IT IS ORDERED that the limitation of the license of Geraldine Grothe, RN, to practice as a professional nurse be, and hereby is, terminated, and Ms. Grothe is restored to full licensure.
