On June 13, 2001, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the request by Jeffrey C. Verzal, R.Ph., for a three-month extension of the stay of suspension of his license to practice pharmacy in the State of Wisconsin, as provided within the board's *Final Decision and Order* dated November 8, 2000, and a request to be allowed to work as a pharmacist-in-charge.

Based upon the board's review of the petition and upon being informed by the department that the necessary reports as required by the Order were not submitted in support of the petition, and that the respondent is currently in violation of paragraph 3 of the *Order*.

IT IS HEREBY ORDERED that Jeffrey C. Verzal, R.Ph., is denied a three-month stay of the suspension of license #8377 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED that the request for modification of the *Order* is DENIED.
