The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Department. The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department of Regulation and Licensing in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Response Security, Inc., 1302 S Broadway, De Pere, WI 54115, is a licensed private detective agency (license #15540). This license was first granted on February 15, 1995.
2. On exact dates unknown but beginning on or about September 15, 1999 and continuing through at least December 10, 1999, Response Security, Inc. employed at least three individuals as private security guards when these individuals were not licensed to perform these services.
3. Response Security, Inc. has cooperated fully with the Department in the investigation of this matter and has taken corrective action to avoid repetition of improper employment of unlicensed personnel.
4. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. By the conduct referred to in ¶¶ 2-6, above, Response Security, Inc., violated sec. 440.26(6)(a)4 and 440.26(8), Stats. and Wis. Admin. Code RL 35.01(13).

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that Response Security, Inc. is **REPRIMANDED**.

IT IS FURTHER ORDERED that the private detective agency license of Response Security Inc. (License #15540) is LIMITED as follows:

Required reporting

1. For a period of two [2] years from the date of this Order, Respondent shall submit reports on a quarterly basis to the Department Monitor in the Department of Regulation and Licensing Division of Enforcement. The quarterly reports shall include a true and accurate accounting of: a) the names and addresses of all employees employed by Respondent as security guards; b) the date of first hire for each such employee; c) their private security license numbers; and d) the dates of security guard work for each employee.

Costs

2. Respondent shall pay partial costs of this proceeding in the amount of THREE HUNDRED dollars (\$300.00). Payment shall be made by certified check or money order, payable to the Wisconsin Department of Regulation and Licensing and sent to the Department Monitor.

Department Monitor

3. The Department Monitor is the individual designated by the Department as its agent to coordinate compliance with the terms of this Order, including receiving quarterly reports and payment of costs. The Department Monitor may be reached as follows:

Termination of restrictions

4. Upon complete, successful and continuous compliance with the terms of this Order, the Department shall restore Respondent's license to full and unrestricted status.

Summary Suspension

5. In the event that Respondent fails to timely comply with the requirements set forth in paragraphs 1 and 2 above, its Wisconsin license to practice as private detective agency shall be SUSPENDED, without further notice or hearing, until it has complied with the terms of this Order. The illegal employment of unlicensed personnel to perform security guard work will result in further disciplinary action against Respondent's license.

6. This Order shall become effective upon the date of its signing.
