The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Larry L. Bosley, MD (DOB 09/19/1931) is duly licensed to practice medicine and surgery in the state of Wisconsin (license #34398). This license was first granted on 06/23/1993. Department records show Dr. Bosley's specialty is dermatology.
2. Dr. Bosley's most recent address on file with the Wisconsin Medical Examining Board is 9100 Wilshire Boulevard, Penthouse, Beverly Hills, CA 90212.
3. On May 4, 1999, the Medical Board of California issued an order that imposed a one-year suspension, stayed the suspension and placed the Respondent on probation for five years. The order was based upon among other things Respondent's use of misleading advertising and staff designations at his hair loss clinics. A true and correct copy of the California Order is attached to this document as Exhibit A.
4. Respondent does not at present own or operate any clinics in the state of Wisconsin.

5. In resolution of this matter, Dr. Bosley consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Wisconsin Medical Examining Board has jurisdiction to act in this matter, pursuant to sec. 448.02(3), Stats., and is authorized to enter into the attached Stipulation and Order, pursuant to sec. 227.44(5), Stats.
2. The conduct described in paragraph 3, above, constitutes a violation of Wisconsin Administrative Code § Med 10.02(q).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the Wisconsin license of Larry L. Bosley, MD (license #34398) is LIMITED as follows:

1. Respondent shall maintain full and complete compliance with all terms, limitations and conditions imposed against his medical license in California.
2. Until otherwise ordered by the Board, Respondent shall REFRAIN from the practice of medicine in the state of Wisconsin (or elsewhere under the use of his Wisconsin license). Respondent shall submit annual reports in a format acceptable to the Board describing the status of his California medical license together with documentation of his compliance with the terms of his probation in California.
3. Respondent may at any time petition the Board for permission to resume the practice of medicine within this state. In conjunction with a petition by Respondent, the Board may require information on the nature of Respondent's intended Wisconsin practice, his advertising, and use of unlicensed staff in his practice. The Board in addition may in its discretion require a personal appearance by Respondent to answer questions in conjunction with his petition. Denial in whole or in part of a petition under this Order shall not constitute denial of a license and shall not give rise to a contested case within the meaning of Wis. Stats. §§227.01(3) and 227.42.
4. The Department Monitor is the individual designated by the Board as its agent to coordinate compliance with the terms of this Order, including receiving and coordinating all reports and petitions. **5. Violation of any of the terms of this Order shall be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license; the Board in its discretion may in the alternative impose additional conditions and limitations other additional discipline for a violation of any of the terms of this Order.**

6. This Order shall become effective on the date of its signing.
