The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Respondent David J. Prohaska, R.Ph. (dob 7/19/47), is and was at all times relevant to the facts set forth herein a registered pharmacist licensed in the State of Wisconsin pursuant to license #8106, originally granted on 2/3/71. Respondent was previously disciplined by the Board in 80 PHM 66 (1984), for having been convicted of misdemeanor theft by fraud (billing fraud upon the Wisconsin Medical Assistance program which respondent committed in his capacity as a pharmacy owner, and for which he was sentenced by the court to pay a fine of \$24,900 plus costs and made restitution of \$20,000) and resulting in a 2 year suspension, of which all but 60 days was stayed, and his license being limited for two years in that he was forbidden to personally perform any third party billings and was to do 150 hours of community service; and again in 88 PHM 42 (1989), for failing to comply with the previous order in that he failed to perform the required community service in a timely manner, resulting in a two week suspension.
- 2. The following were, at all times relevant to the facts set forth herein, licensed as pharmacies in the State of Wisconsin: Balsam Lake Pharmacy, license # 7866; James Pharmacy, license #6846; James Pharmacy license #6845; Shell Lake Pharmacy license #6461; and Miller Pharmacy license #4488; and are and were owned by respondent Prohaska.
- 3. Respondent Prohaska did not install centrally monitored alarm systems in respondent pharmacies by January 1, 2000 as required by § Phar 6.08, Wis. Adm. Code, which was adopted in December, 1998, and effective 1/1/99. Notice of this rule was published in the *Wisconsin Regulatory Digest* in April of 1999, and again in September of 1999. All respondents received these two *Regulatory Digests*.
- 4. The pharmacies did not have such alarms until the following dates:

5. Each day of non-compliance in each pharmacy constitutes a separate violation.

CONCLUSIONS OF LAW

- A. The Wisconsin Pharmacy Examining Board has jurisdiction to act in this matter pursuant to §450.10, Wis. Stats. and is authorized to enter into the attached Stipulation pursuant to §227.44(5), Wis. Stats.
- B. The conduct described in paragraph 3 & 4, above, violated § Phar 6.08. Such conduct constitutes unprofessional conduct within the meaning of the Code and statutes.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is accepted.

IT IS FURTHER ORDERED, that David J. Prohaska, R.Ph., is REPRIMANDED for his unprofessional conduct in this matter.

IT IS FURTHER ORDERED, that the respondents shall jointly and severally FORFEIT \$19,640.00, to be paid within 30 days of this order.

IT IS FURTHER ORDERED, that respondents shall jointly and severally pay COSTS in this matter in the amount of \$500.00, within 30 days of this order.

IT IS FURTHER ORDERED, that pursuant to §227.51(3), Wis. Stats., and ch. RL 6, Wis. Adm. Code, if the Board determines that there is probable cause to believe that respondent has violated any term of this Final Decision and Order, the Board may order that the license of respondent be summarily suspended pending investigation of the alleged violation.
