The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

**FINDINGS OF FACT**

1. Jo Ann M. Kulasiewicz (DOB 08/11/1959; 1433 S. 86<sup>TH</sup> Street, West Allis, WI 53214) is duly licensed as a Barbering and Cosmetology manager (License #16487). This license was first granted on 08/06/1984.
2. At all times relevant to this action, Respondent was working at Regis Salon #4889, 2500 North Mayfair Road, Wauwatosa, WI 53226, a barbering and cosmetology establishment in the state of Wisconsin (license #28751).
3. On or about November 21, 2000, inspection of Regis Salon #4889 revealed that Respondent's workstation at the establishment was not maintained in a clean and sanitary condition, as required by Wis. Admin. Code §BC 4.01(1).
4. In resolution of this matter, Jo Ann M. Kulasiewicz consents to the entry of the following Conclusions of Law and Order.

**CONCLUSIONS OF LAW**

By the conduct referred to in ¶ 3, above, Jo Ann M. Kulasiewicz is subject to discipline pursuant to secs. 454.15(2)(i), Stats. and Wis. Admin. Code § BC 4.01(1).

# ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that

1. Within thirty [30] days from the date of this order, Respondent shall pay to the Department of Regulation and Licensing a forfeiture of ONE HUNDRED dollars (\$100.00).
2. Within thirty [30] days from the date of this order, Respondent shall pay to the Department of Regulation and Licensing partial costs of these proceedings in the amount of ONE HUNDRED dollars (\$100.00).
3. Payment shall be made by ***certified check or money order***, payable to the Wisconsin Department of Regulation and Licensing and sent to: Department Monitor, Division of Enforcement, PO Box 8935, Madison, WI 53708-8935
- 4. In the event Jo Ann M. Kulasiewicz fails to timely pay the forfeiture and costs set forth above, her manager's license (#16487) SHALL BE SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of this Order.**
5. This Order shall become effective upon the date of its signing.
