The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Vicky Maynard (DOB 12/06/1957; 1357 North 58th Street, Milwaukee, WI 53208) is duly licensed as a Barbering and Cosmetology manager (License #16079). This license was first granted on 08/08/1983.
2. At all times relevant to this action, Respondent was working as a barbering and cosmetology establishment in the state of Wisconsin (license #28751).
3. Respondent's barbering and cosmetology manager's license expired July 1, 1997. On exact dates unknown, but at least between October 2, 2000 and January 4, 2001 Respondent worked part time performing barbering and cosmetology services at Regis Salon #4889, 2500 North Mayfair Road, Wauwatosa, WI 53226. Respondent renewed her barbering and cosmetology license effective January 24, 2001.
4. In resolution of this matter, Vicky Maynard consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

By the conduct referred to in ¶ 3, above, Vicky Maynard is subject to discipline pursuant to sec. 454.04(1) Stats.

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that

1. Within thirty [30] days from the date of this order, Respondent shall pay to the Department of Regulation and Licensing a forfeiture of ONE THOUSAND dollars [\$1,000.00]. Payment shall be submitted in ten [10] installments of one hundred dollars [\$100]. Each installment shall be due on the 15th of the month, beginning with the month immediately following the effective date of this order. Payment shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to: Department Monitor, Division of Enforcement, PO Box 8935, Madison, WI 53708-8935.
- 2. In the event Vicky Maynard fails to timely pay the forfeiture and costs set forth above, her manager's license (#16079) SHALL BE SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of this Order.**
3. This Order shall become effective upon the date of its signing.
