The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

#### **FINDINGS OF FACT**

- 1. Regis Salon #4889, 2500 North Mayfair Road M-185, Wauwatosa, WI 53226, is duly licensed as a barbering and cosmetology establishment in the state of Wisconsin (license #28751). This license was first granted on November 24, 1999.
- 2. Regis Corporation, 7201 Metro Blvd., Minneapolis, MN 55439, is listed with the Department of Regulation and Licensing as the owner of Regis Salon #4889. As owner, Regis Corporation was and is at all times relevant to this action responsible for compliance with ch. 454, Stats. and Wisconsin Administrative Code chs. BC 2, 3 and 4.
- 3. On or about November 21, 2000, inspection of Regis Salon #4889 revealed the following:
  - a. Workstations at the establishment were not maintained in a clean and sanitary condition, as required by Wis. Admin. Code §BC 4.01(1); and
  - b. The establishment had in its employ a practitioner (Vicky Maynard) whose license had expired June 30, 1997.
- 4. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

### **CONCLUSIONS OF LAW**

By the conduct referred to in ¶ 3, above, Regis Corporation, d/b/a Regis Salon #4889 violated secs. 454.04(1) and 454.15(2)(i), Stats. and Wis. Admin. Code §§ BC 2.04(1), BC 2.06 and BC 4.01(1).

#### **O**RDER

#### NOW, THEREFORE, IT IS HEREBY ORDERED that

- 1. Respondent shall pay to the Department of Regulation and Licensing a forfeiture of ONE THOUSAND ONE HUNDRED dollars (\$1,100.00). Payment shall be submitted within thirty [30] days from the date of this order. Payment shall be made by *certified check or money order*, payable to the Wisconsin Department of Regulation and Licensing and sent to: Department Monitor, Division of Enforcement, PO Box 8935, Madison, WI 53708-8935
- 2. In the event Regis Corporation fails to timely pay the forfeiture set forth in ¶ 1 above, the establishment license of Regis Salon #4889 (license #28751) SHALL BE SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of this Order.
- 3. This Order shall become effective upon the date of its signing.
