On April 6, 2001, the Board of Nursing issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent's license to practice as a registered nurse in Wisconsin was limited to require that he complete an approved course of training in nursing ethics and provide work reports prepared by his employer for a period of one year.

On June 9, 2001, the board considered evidence that Mr. Larson had not complied with the terms of the board's Order due to health reasons, and considered as well Mr. Larson's request that the board accept the voluntary surrender of his license. Based upon all information of record herein, it is ordered as follows:

### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the voluntary surrender of the license of Terrance L. Larson, RN, to practice as a professional nurse in Wisconsin be, and hereby is, accepted.
