The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

#### FINDINGS OF FACT

- 1. A deline Villiard (D.O.B. 08/20/37) is duly licensed as a practical nurse in the state of Wisconsin (license # 1905).
- 2. Respondent's most recent address on file with the Wisconsin Board of Nursing is PO Box 61, Radisson, WI 54867.
- 3. At all times relevant to this action, Respondent was working as a licensed practical nurse at Ladysmith Nursing Home, 1001 East 11<sup>th</sup> Street N, Ladysmith, Wisconsin. The Division of Enforcement has received allegations that on or about February 13, 2000, Respondent interacted with a resident of the nursing home in a manner inappropriate with nursing standards.
- 4. Respondent has retired from nursing. Without admitting or denying the allegations against her, Respondent consents to the following Conclusions of Law and Order in resolution of this matter.

#### **CONCLUSIONS OF LAW**

- 1. The Wisconsin Board of Nursing has jurisdiction over this matter, pursuant to sec. 441.07, Stats.
- 2. The Wisconsin Board of Nursing is authorized to enter into the attached stipulation, pursuant to sec. 227.44(5), Stats.
- 3. Respondent's conduct on February 13, 2000 constitutes a basis for discipline under secs. 441.07(1) and Wisconsin Administrative Code § N 7.04(4) and (15). Furthermore, the Findings of Fact set forth above in paragraph 3 constitute an agency finding within the meaning of secs. 48.685 and 50.065, Wis. Stats.

### **ORDER**

**NOW, THEREFORE, IT IS HEREBY ORDERED** that Adeline Villiard shall SURRENDER her license to practice as a licensed practical nurse in the state of Wisconsin (license #1905).

IT IS FURTHER ORDERED that should Ms. Villiard reapply for Wisconsin licensure, the Board may in its sole discretion determine whether, and under what terms and conditions, this license may be reissued.

This Order shall become effective upon the date of its signing.
