THE LIMITED LICENSE

On August 2, 2001, the Board of Nursing issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent's license to practice as a registered nurse in Wisconsin was limited in part to require that within 90 days from the date of the Order, respondent submit documentation of a current AODO assessment establishing that he may safely and competently practice as a professional nurse in Wisconsin, and to require as well that he participate in an approved drug treatment program if recommended by the assessment.

On December 6, 2001, the board considered evidence of respondent's failure to submit the results of the AODA assessment required by the board's Order. Accordingly, it is ordered as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that, pursuant to the summary suspension provisions of the board's Final decision and Order in this matter dated August 2, 2001, the license of Bruce E. Walley, RN, to practice as a registered nurse in Wisconsin is hereby suspended, effective on the date hereof.
