The parties in the matter agree to the terms and conditions of the attached Stipulation as the final decision of the matter, subject to the approval of the Board. The Board has reviewed the stipulation and considers it acceptable.

Accordingly, the Board in the matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. GLAMOUR NAILS, 2350 E. Mason Street #26, Green Bay, WI 54302, is duly licensed as a Manicuring Establishment in the State of Wisconsin (license #71-1172). The license was first granted on March 27, 1998.
2. ANTONIO H. LE is listed with the Department of Regulation and Licensing as the owner of GLAMOUR NAILS. Le is a licensed manicurist, having received his license (#85-2934) on June 4, 1997. The last known address for ANTONIO H. LE in the Department of Regulation records is 2350 E. Mason Street #26, Green Bay, WI 54302.
3. As the owner of a licensed manicuring establishment, Mr. Le was at all times relevant to the action responsible for compliance with ch. 454, Stats. and Wisconsin Administrative Code chs. BC 2, 3 and 4.

4. On exact dates unknown, but beginning at least on April 12, 2001, clean, sanitary and safe conditions were not maintained at the Glamour Nails establishment. On that date, the Department of Regulation inspected the establishment in response to a complaint filed by a customer alleging unsanitary conditions, specifically, that the customer got a nail infection as a result of the unsanitary conditions at the establishment.

5. During the inspection by the Department, conducted on April 12, 2001, the Investigator found that the used nail files were not thrown away but were placed in a container containing the clean and unused files.

6. An order to correct was issued and subsequently signed and returned by Mr. Le.

7. In resolution of the matter, Antonio H. Le consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

By the conduct referred to in the paragraphs above, **ANTONIO H. LE, d/b/a GLAMOUR NAILS**, has violated the following:

1. Wis. Admin. Code BC 4.02 (3a) and 4.03 (4) by failing to store sterilized equipment in a covered container and not disposing of equipment that cannot be cleaned with soap or detergent.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the establishment license of **GLAMOUR NAILS (#71-1172)** and the manicurist license of **ANTONIO H. LE (# 85-2934)** shall be **REPRIMANDED**.

IT IS FURTHER ORDERED that **ANTONIO H. LE d/b/a GLAMOUR NAILS** shall pay to the Department of Regulation and Licensing a forfeiture of **ONE HUNDRED** dollars (**\$100.00**).

Payment of the forfeitures shall be submitted within **30 days** from the date of this Order. Payment shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to: **Department Monitor, Division of Enforcement, PO Box 8935, Madison, WI 53708-8935**.

IT IS FURTHER ORDERED that in the event **ANTONIO H. LE** fails to timely submit payment of the forfeiture as set forth above, the establishment license of **GLAMOUR NAILS (71-1172)** **SHALL BE SUSPENDED**, without further notice or hearing, until compliance has been gained. This Order shall become effective upon the date of its signing.
