The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Khen Tri (DOB 10/30/1970) 6226 Jeffers Drive, Madison, WI 53719 is duly licensed as a manicurist in the state of Wisconsin (license #2886). This license was first granted on April 14, 1997.
2. Kimberly Nails, 2604 Allen Boulevard, Middleton, WI 53562, is duly licensed as a manicuring establishment in the state of Wisconsin (license #985). This license was first granted on August 13, 1997. Khen Tri is listed with the Department of Regulation and Licensing as the owner of Kimberly Nails. As owner, Mr. Tri is and was at all times relevant to this action responsible for compliance with ch. 454, Stats. and Wisconsin Administrative Code chs. BC 2, 3 and 4.
3. An inspection of Kimberly Nails on April 20, 2001 revealed that the nail brush disinfectant was not being changed on a daily basis, and used nail files were not properly disposed of after use.
4. In resolution of this matter, Mr. Tri consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

By the conduct referred to in ¶ 3, above, Khen Tri, d/b/a Kimberly Nails, violated sec. 454.15(2)(i) and Wis. Admin. Code §§ 4.02(4) and 4.10(1)(b).

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that Khen Tri, d/b/a Kimberly Nails, shall pay to the Department of Regulation and Licensing a forfeiture of ONE HUNDRED dollars (\$100.00). Payment shall be submitted within 30 days from the date of this order. Payment shall be made by ***certified check or money order***, payable to the Wisconsin Department of Regulation and Licensing and sent to:

**IT IS FURTHER ORDERED** that in the event Respondents fail to timely submit any payment of the forfeiture as set forth above, the establishment license of Kimberly Nails (#985) **SHALL BE SUSPENDED**, without further notice or hearing, until Respondents have complied with the terms of this Order.

This Order shall become effective upon the date of its signing.
