The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

# **FINDINGS OF FACT**

- 1. Travis Parr, ("Parr"), W13675 Fly Creek Road, Wisconsin 54616 is licensed as an auctioneer in the State of Wisconsin pursuant to license #52-743, originally granted to him on March 8, 1995.
- 2. Parr's auctioneer license was in an expired status from January 1, 1997 through March 21, 2001.
- 3. Parr performed activities that required a Wisconsin auctioneer license during the period of time he was not actively licensed in Wisconsin.

## **CONCLUSIONS OF LAW**

- 1. The Wisconsin Auctioneers Board has jurisdiction to act in this matter pursuant to sec. 480.24, Wis. Stats.
- 2. The Wisconsin Auctioneers Board is authorized to enter into the attached Stipulation pursuant to sec. 227.44(5), Wis. Stats.
- 3. Respondent Travis Parr has violated section 480.08 of the Wisconsin Statutes by engaging in conduct requiring

a current auctioneer registration at a time that he was not licensed. Parr is subject to discipline pursuant to section 480.24(2)(j) of the Wisconsin Statutes.

#### **ORDER**

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED, that Travis Parr, auctioneer certificate number 52-743 is REPRIMANDED.

**IT IS FURTHER ORDERED**, that Respondent **Travis Pa**rr pay a **FORFEITURE** of \$500.00 within thirty (30) days of the date of this Order by making payment of the same to the Department of Regulation and Licensing, P.O. Box 8935, Madison, WI 53708-8935.

**IT IS FURTHER ORDERED,** that in the event **Travis Parr** fails to pay the above forfeiture of \$500.00 within the time and in the manner as set forth above, then his Auctioneers license shall be suspended, without further notice, hearing or order of the Board, and said suspension shall continue until the full amount of said forfeiture has been paid to the Department of Regulation and Licensing, and his failure to pay the forfeiture shall be considered a violation of this Order by the Board and may result in further discipline under section 480.24 of the Wisconsin Statutes.

**IT IS FURTHER ORDERED**, that Respondent **Travis Parr** pay partial **COSTS** of this matter in the amount of \$250.00 within thirty (30) days of the date of this Order by making payment of the same to the Department of Regulation and Licensing, P.O. Box 8935, Madison, WI 53708-8935.

**IT IS FURTHER ORDERED**, that in the event **Travis Parr** fails to pay costs of \$250.00 within the time and in the manner as set forth above, then his Auctioneers license shall remain suspended, without further notice, hearing or order of the Board, and said suspension shall continue until the full amount of said costs have been paid to the Department of Regulation and Licensing, and his failure to pay the costs shall be considered a violation of this Order by the Board and may result in further discipline under section 480.24 of the Wisconsin Statutes.

IT IS FURTHER ORDERED, that file #00 AUC 036 be, and hereby is, closed as to Travis Parr.
