The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. On or about July 31, 2000, the Barbering and Cosmetology Examining Board issued Angela R. Bonjour, 807 Topaz Lane, Madison, WI 53714, an initial apprenticeship permit (permit #77086). Ms. Bonjour's permit was canceled on July 6, 2001.
2. On August 30, 2001, Ms. Bonjour submitted a request for an extension of her barbering and cosmetology apprenticeship permit to allow her time to complete her theory and practical training hours.
3. In resolution of this matter, Ms. Bonjour consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter, pursuant to secs. 454.15(2) and 454.10, Stats. and is authorized to enter into the attached Stipulation and Order, pursuant to sec. 227.44(5), Stats.

# ORDER

**NOW, THEREFORE, IT IS HEREBY ORDERED** that the application of Angela R. Bonjour, for an extension of her barbering and cosmetology apprentice permit shall be granted, **subject to the following terms and conditions:**

## Application

1. Ms. Bonjour shall arrange for the completion of all necessary paperwork for the activation of her apprenticeship permit with the Department of Workforce Development. Ms. Bonjour may not commence work as an apprentice until the requirements of this paragraph are satisfied.

## Attendance

2. Ms. Bonjour must maintain current enrollment in and uninterrupted attendance at an acceptable provider of theory instruction for barbering and cosmetology.

3. Ms. Bonjour must maintain satisfactory work attendance at Cost Cutters, her place of practical training.

## Reports.

3. During the time that Ms. Bonjour holds an apprenticeship permit she shall arrange for submission of the following reports **on at least a monthly basis:**

a) Current documentation of satisfactory enrollment in school; school attendance and progress in school; and

b) Current documentation of satisfactory work attendance and training.

4. All documentation [including proof of enrollment, school attendance, and work reports] shall be submitted to Field Representative Mary Pierce, Bureau of Apprenticeship Standards, Department of Workforce Development, 819 N. 6th St., Room 516, Madison, WI 53203; Tel. (414) 227-4973.

## Permit expiration.

5. The apprenticeship permit shall be extended through no later than July 31, 2003. This extension will allow Ms. Bonjour an opportunity to complete her theory hours as an apprentice. Ms. Bonjour must enroll for the spring semester and fall semester 2002 as well as the spring semester 2003 to complete her theory hours.

## Completion of training

6. Immediately following completion of her theory and practical instruction, Ms. Bonjour shall contact Continental Testing Service [(800) 359-1313] to schedule her licensure examination and obtain a temporary permit. A temporary permit is required in order to continue practicing after theory and practical instruction is completed.

## IT IS FURTHER ORDERED THAT

IN THE EVENT THAT THE BOARD RECEIVES NOTIFICATION FROM THE DEPARTMENT OF WORKFORCE DEVELOPMENT THAT ANGELA R. BONJOUR HAS FAILED TO MAINTAIN SATISFACTORY SCHOOL ATTENDANCE AND PROGRESS IN SCHOOL OR THAT MS. BONJOUR HAS FAILED TO MAINTAIN SATISFACTORY WORK ATTENDANCE AND PARTICIPATION IN TRAINING, THE APPRENTICESHIP PERMIT GRANTED TO MS. BONJOUR (#17086) **SHALL BE REVOKED**, WITHOUT FURTHER NOTICE OR HEARING, AND MS. BONJOUR MUST THEN IMMEDIATELY CEASE PRACTICING BARBERING AND COSMETOLOGY.

This Order shall become effective on the date of its signing.
