The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Mai Tuyet Dong (DOB May 21, 1979) of 1123 Glades Drive, Altoona, WI 54720 is duly licensed as a manicurist in the state of Wisconsin (License #4311). This license was first granted on October 9, 2000.
- 2. At all times relevant to this action, Respondent was working as a manicurist at Lees Nails, 4800 Golf Road, Eau Claire, WI 54701, a manicuring establishment in the state of Wisconsin (license #1742).
- 3. On August 22, 2001, inspection of Lees Nails revealed that Ms. Dong did not wash her hands between clients, as required by Wis. Admin. Code §BC 4.01(2).
- 4. In resolution of this matter, Mai Tuyet Dong consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

By the conduct referred to in ¶ 3, above, Mai Tuyet Dong is subject to discipline pursuant to secs. 454.15(2)(i), Stats. and Wis. Admin. Code § BC 4.01(2).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that

- 1. Ms. Dong shall pay to the Department of Regulation and Licensing a forfeiture of ONE HUNDRED dollars (\$100.00). Payment shall be submitted within 30 days from the effective date of this Order.
- 2. Payment shall be made by certified check or money order, payable to the Wisconsin Department of Regulation and Licensing and sent to:

3. In the event Ms. Dong fails to timely pay the forfeiture set forth above, her manicurist license (#4311) SHALL BE SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of this Order.
