The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

# **FINDINGS OF FACT**

- 1. Blues Hair Studio, 1635 North Central Avenue, Marshfield, WI 54449, is duly licensed as a barbering or cosmetology establishment in the state of Wisconsin (license #30005). This license was first granted on August 22, 2001.
- 2. Irene Schreiber, 310 West Clark Street, Unity, WI 54488, is listed with the Department of Regulation and Licensing as the owner of Blues Hair Studio. As owner, Ms. Schreiber was and is at all times relevant to this action responsible for compliance with ch. 454, Stats. and Wisconsin Administrative Code chs. BC 2 and 3.
- 3. On exact dates unknown, but between at least July 2000 and August 22, 2001, Blues Hair Studio provided cosmetology services to the public. Ms. Schreiber did not obtain a license for this establishment until August 22, 2001.
- 4. In resolution of this matter, Irene Schreiber consents to the entry of the following Conclusions of Law and Order.

### **CONCLUSIONS OF LAW**

By the conduct referred to in ¶ 3, above, Irene Schreiber, d/b/a Blues Hair Studio, violated secs. 454.08(1)(b) and 454.15(2)(i), Stats. and Wis. Admin. Code §§ BC 2.045(1), and BC 3.01(1).

#### **ORDER**

# NOW, THEREFORE, IT IS HEREBY ORDERED that

- 1. Ms. Schreiber shall pay to the Department of Regulation and Licensing a forfeiture of ONE THOUSAND dollars (\$1,000.00). Payment shall be made by *certified check or money order*, payable to the Wisconsin Department of Regulation and Licensing and sent to: Department Monitor, Division of Enforcement, PO Box 8935, Madison, WI 53708-8935.
- 2. Payment shall be submitted by at least the following schedule:

- 3. In the event Irene Schreiber fails to timely pay the forfeiture set forth in ¶ 1 above, the establishment license of Blues Hair Studio (#30005) SHALL BE SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of this Order.
- 4. This Order shall become effective upon the date of its signing.
