An informal settlement conference was conducted in the above-captioned matter before an informal settlement conference committee of the Medical Examining Board on August 23, 2000. A Stipulation and Order were thereafter executed by the parties, by which Dr. Smith was required, within 120 days of the date of the board's Order adopting this Stipulation, to complete not less than 120 hours of community medical service approved in advance by the board. The board subsequently granted a six month extension of the deadline for completing the community service.

Dr. Smith appeared before the board on October 17, 2001, accompanied by his attorney, Kristin D. Lein, in support of his request for a further extension in the deadline for completing the community service. Based upon that request, and upon other information of record herein, the board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the deadline for completing community service in this matter is extended for a further 120 day period, commencing on the date upon which Dr. Smith submits a request for approval of a community service commitment or one month from the date hereof, whichever is sooner. The board will consider any appropriate community service undertaking.
