DENIAL OF A REQUEST FOR REINSTATEMENT

On October 11, 1996, the Funeral Directors Examining Board issued its *Final Decision and Order* in the above-captioned matter. Under the terms of that Order, Mark R. Laemmrich's license to practice as a funeral director was revoked for a period of three years. After three years, the Order provides that Mr. Laemmrich may petition the Board for reinstatement and may be required to demonstrate rehabilitation, among other things.

At its meeting on November 6, 2001, the Board reviewed Mr. Laemmrich's request for the reinstatement of his funeral director's license, along with a variety of supporting materials. The Board also reviewed the materials provided by the Wisconsin Department of Corrections regarding Mr. Laemmrich's probation term, which he served as a result of his felony conviction for Theft and Forgery.

Based on the seriousness of Mr. Laemmrich's conviction and the recommendation from the Department of Corrections against reinstatement, the Board does not believe that he has demonstrated sufficient rehabilitation such that his license to practice as a funeral director should be reinstated.

NOW THEREFORE IT IS HEREBY ORDERED that Mark R. Laemmrich's request for the reinstatement of his funeral director's license is hereby **DENIED**.
