A meeting of the State of Wisconsin Pharmacy Examining Board was held on March 14, 2001, during which the board reviewed a request by Robert V. Guzzetta for reinstatement of his license to practice pharmacy. Mr. Guzzetta appeared personally before the board, and his request was supported by other correspondence and documentation. By a *Final Decision and Order* ("*Order*") dated September 13, 1994, the State of Wisconsin Pharmacy Examining Board ordered the suspension of respondent's license for a period of not less than five (5) years. The decision provided for successive three (3) month stays of the suspension upon petition by respondent and continuing compliance with the terms of the Order, which included a requirement that he participate in a program of random, witnessed collection of urine and/or blood specimens for the presence of controlled substances and alcohol upon a frequency of not less than eight (8) times per month for the first year of the order.

Based upon the board's review of the information presented,

IT IS HEREBY ORDERED: that the license of the respondent, Robert V. Guzzetta, to practice pharmacy shall be and hereby is reinstated as limited herein, effective the date of this order. A three month stay of suspension is granted under the terms of the *Order* effective the date of this order.

Limitations:

- 1. The respondent's license to practice pharmacy is limited to practicing as a nuclear pharmacist in a nuclear pharmacy only.
- 2. The respondent shall practice under and comply with all of the terms of the *Order* for a period of not less than five (5) years from the date of signing of this order.
- 3. For the first seven hundred (700) hours of employment as a nuclear pharmacist, the respondent shall work under the direction, control and general supervision of a pharmacist who shall check respondent's work product and take responsibility therefor, signing as the responsible pharmacist for the respondent's work product.
- 4. Within four (4) months of the date of this order, the respondent shall submit evidence to the board or its designee of the successful completion of sixty (60) hours of continuing education, such hours to be in addition to and not to count toward the required continuing education for renewal as provided in Wis. Adm. Code chapter Phar 16.
- 5. Within four (4) months of the date of this order, the respondent shall successfully pass the multi-state pharmacy jurisprudence examination as provided in Wis. Adm. Code section Phar 4.02 (1).
