On August 14, 2001, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the request by Charlene Willis, R.Ph., for a three month stay of suspension, as provided within the board's *Final Decision and Order* ("*Order*") dated October 10, 1995, and the board's subsequent order of November 8, 2000. The board reviewed the department's therapy report form dated July 19, 2001, prepared by William J. Sullivan, M.D., indicating that the respondent is in violation of paragraph 2b(2) of the *Order* which requires the respondent to attend individual and/or group therapy sessions not less than once weekly. The board finds that during the four months prior to the present petition the respondent attended therapy on the following dates: 7/16/01, 6/4/01, 4/19/01.

Based upon the foregoing,

IT IS HEREBY ORDERED; that based upon a violation of paragraph 2b(2) of the *Order* Charlene Willis, R.Ph., is denied a three month stay of the suspension of license number 11555 to practice pharmacy in the State of Wisconsin.
