ORDER RESTORING FULL LICENSURE

On May 1, 1996, the Dentistry Examining Board issued its Final Decision and Order in the above-captioned matter. By the terms of the Board's Order, Respondent's license was indefinitely suspended with the possibility of stays at three-month intervals. The Order also provided that upon a showing by Respondent of complete, successful, and continuous compliance with the conditions of the stay that he would be entitled to a return of his full license.

On May 2, 2001, the Board considered Brian J. Blocher's request that the limitations on his license be terminated. Based upon that request and upon evidence of Dr. Blocher's full compliance with the terms and conditions on his license,

NOW, THEREFORE, IT IS HEREBY ORDERED that all the limitations on the license of Brian J. Blocher to practice as a dentist in Wisconsin are lifted and he is restored to full licensure.
