ORDER ADOPTING STIPULATION

Applicant

On October 22, 1997, the Medical Board filed its Final Decision and Order in the above-captioned matter, by which the board accepted the voluntary surrender of Dr. Tong's license to practice medicine and surgery in Wisconsin. By letter dated August 7, 2000, Dr. Tong, by Attorney Stephen J. McManus, petitioned the board for reinstatement of his license. Dr. Tong and Attorney Richard J. Cayo appeared before the board on September 20, 2000, in support of the petition. After considering the petition, the board tabled the matter, and ordered that Dr. Tong could renew his petition, and the Medical Examining Board would further consider the petition, upon receipt by the board of a Multidisciplinary Assessment Report from Rush Behavioral Health Center - DuPage, 2001 Butterfield Road, Suite 320, Downers Grove, IL 60515, telephone (630) 515-4420. The assessment was to include a general psychiatric evaluation, a screen for the presence of substance abuse/dependence, an assessment of his proclivity to engage in inappropriate sexual behavior with patients, an evaluation of his fitness for practice and, if indicated, treatment recommendations.

On April 18, 2001, the board again considered Dr. Tong's petition, based upon receipt of the required assessment performed by Rush Behavioral Health Center. The board and Dr. Tong thereafter entered into a Stipulation, by which the board agreed to issue, and Dr. Tong agreed to accept, a limited license to practice medicine and surgery in Wisconsin. Based upon that Stipulation, it is ordered as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that Dr. Tong is granted a limited license to practice medicine and surgery in Wisconsin imposing the following terms and conditions:

1. Dr. Tong shall sit for and successfully complete the Special Purpose Examination (SPEX), administered by the Federation of State Medical Boards.
2. Within six months following the effective date of his limited license, Dr. Tong shall enroll in and successfully complete the boundaries course offered by the University of Minnesota School of Medicine.
3. Dr. Tong shall participate in the Physicians Assistance Program offered in whatever state he chooses to practice.
4. Dr. Tong shall practice only in a group, clinic or hospital setting until relieved of this limitation by the board.
5. Dr. Tong shall come under the care of a primary care physician for routine health maintenance and management of his health problems. With the exception aspirin, anti-inflammatory agents and antacids, all medication he takes must be authorized by a physician with whom he has a formal physician-patient relationship.
6. The effective date of the limited license shall be the date upon which the board is notified that Dr. Tong has passed FLEX.
