ORDER GRANTING

STAY OF SUSPENSION

---

On February 10, 1998, the Board of Nursing issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent's license to practice as a registered nurse in Wisconsin was suspended for a period of three years. The Order provided that Ms. Danaher-Dunn could petition for stay of the suspension of the license after one year upon submission to the board of evidence that she is able to safely and competently return to the active practice of nursing. The Order further provided that upon such a showing, the board could grant a three month stay of the suspension, with provision for further extensions of the stay conditioned upon compliance with certain conditions and limitations on the license.

By letter dated September 25, 2000, Ms. Danaher-Dunn requested that she be permitted to appear before the board in support of her request for a stay of the suspension of her license. She appeared before the board on November 3, 2000, and the board granted the stay on that date.

On March 1, 2001, the board considered Ms. Danaher-Dunn's request for a further stay of the suspension of her license.

Based upon her request and other information of record, **IT IS HEREBY ORDERED** that the suspension of the license of Patricia Danaher-Dunn, R.N., is stayed for a period of three months. Ms. Danaher-Dunn may petition for further three month stays of the suspension, which shall be granted upon satisfactory demonstration of having complied with all terms and conditions imposed by the board's February 10, 1998, Final Decision and Order during the preceding three month period.
