On March 26, 1998, the Wisconsin Real Estate Board issued a *Final Decision and Order* ("Order") by which it suspended the real estate broker's license of the respondent. On February 22, 2001, the board reviewed a request by the respondent for the suspension to be terminated pursuant to the terms of a subsequent order of the board dated December 15, 1998, which modified the original *Order*.

Accordingly, based upon a review of the information received and the record in this matter;

IT IS ORDERED that the suspension of Joyce E. Anderson's real estate broker's license, number 31263 is terminated, and IT IS FURTHER ORDERED that Joyce E. Anderson be eligible to renew her real estate broker's license, number 31263.
