The State of Wisconsin Department of Regulation and Licensing, having considered the record in the above captioned matter, makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. On November 16, 2000, the Wisconsin Department of Regulation and Licensing (department) issued an Order Adopting Stipulation granting a limited private security guard permit to Joseph D. Lynch. Among other things, the Order Adopting Stipulation limits the registration of Joseph D. Lynch by requiring that Joseph D. Lynch file quarterly reports with the Department providing information concerning his employment, arrest and conviction record, job performance and compliance with the terms of his probation. Paragraph 3. of the Order Adopting Stipulation requires that quarterly reports be filed within 5 days after the following dates: March 1, 2001; June 1, 2001; September 1, 2001; December 1, 2001 and every March 1, June 1, September 1 and December 1 until further order of the department. A copy of the Order Adopting Stipulation is annexed hereto.
2. The Order Adopting Stipulation further provides that the failure of Joseph D. Lynch to comply with the limitation in the Order Adopting Stipulation shall result in the revocation of his limited private security guard permit without further notice or hearing or other proceedings.
3. Marlene Meyer is an employee of the Department whose job title is "Department Monitor" and whose responsibilities include receiving and monitoring reports from credential holders who hold a limited credential and who are required to file reports with the Department.
4. On or about March 6, 2001, Marlene Meyer wrote to Joseph D. Lynch, stating in part that:

"To date, you have failed to have the following filed with the Division of Enforcement in your behalf:

The quarterly reports as outlined in paragraph 3 of the Order.

Please submit the requested reports by March 16, 2001. Failure to return the reports will cause this matter to be referred to Division of Enforcement as a possible violation of the Board order.

5. As of the date of this order, Joseph D. Lynch has not filed the reports required by the Order Adopting Stipulation.

CONCLUSIONS OF LAW

1. The failure of Joseph D. Lynch to file reports as required by the Department's order and described in the Findings of Fact, above, constitutes a failure to comply with the terms of the limitation in the Order Adopting Stipulation.
2. The State of Wisconsin Department of Regulation and Licensing has jurisdiction in this proceeding under Chapter 440, Stats., and the provisions in the Order Adopting Stipulation.
3. The State of Wisconsin Department of Regulation and Licensing has authority to issue the following Order under Chapter 440, Stats., and the provisions in the Order Adopting Stipulation.

ORDER

NOW, THEREFORE, IT IS ORDERED that the registration of Joseph D. Lynch to practice as a private security guard is REVOKED.
