On January 25, 2001, the State of Wisconsin Real Estate Board reviewed information presented to it that Randall G. Stumpf has failed to comply with the board's *Final Decision and Order*, ("Order") (LS 9812104 REB) dated December 10, 1998, by failing to timely complete board ordered education and payment of a \$250 forfeiture under the terms of the *Order*.

The board's *Order*, further provides, "IT IS FURTHER ORDERED, that in the event that Respondent, Randall G. Stumpf, fails to comply with the education or forfeiture payment as required above, his real estate licenses shall be suspended, without further notice, hearing or order of the Board, until such compliance is demonstrated."

Based upon the board's review of the information received,

IT IS HEREBY ORDERED: That pursuant to the *Order*, the real estate broker license of Randall G. Stumpf, #90-35823, is suspended.
