On March 14, 2001, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the request by Ralph G. Koch, R.Ph., for a three-month extension of the stay of suspension, as provided within the board's *Final Decision and Order* ("*Order*") dated June 16, 1999, and that the board remove the provisions from the *Order* that another pharmacist review Koch's work (Part I (b)), and to reduce the frequency of visits to his psychiatrist to once every month.

Based upon the board's review,

IT IS HEREBY ORDERED that Ralph G. Koch, R.Ph., is granted a three-month stay of the suspension of license #9023 to practice pharmacy in the State of Wisconsin, and a reduction in the frequency of visits to his psychiatrist to once every month. The request that the board remove the provisions from the *Order* that another pharmacist review Koch's work (Part I (b)), is denied.

IT IS FURTHER ORDERED: that Mr. Koch may not repetition the board for any further modifications of the *Order* until January, 2002.
