On December 13, 2001, the Wisconsin Chiropractic Examining Board reviewed the Petition for Termination of Suspension filed by Dr. Arnold, along with the reports of David E. Seymour, MDE, CICSW, and Timothy D. Schultz, Ph.D. Because the two reports contain conflicting information and conclusions regarding Dr. Arnold's ability to practice safely if the current suspension is terminated, the board denies the petition at this time.

At any time following this order, when he and his counselor(s) consider it appropriate, Dr. Arnold may obtain another assessment, following the procedure of section 3 of the September 2, 1999 order. Dr. Arnold may propose a mental health care provider to be approved by the board or he may contact the departmental monitor for a list of approved evaluators. Dr. Arnold may file another petition for termination of suspension when the report is available.

IT IS ORDERED that the Petition for Termination of Suspension is denied.
