RESPONDENT	FULL LICENSURE

On January 5, 2000, the Dentistry Examining Board issued its Final Decision and Order in the above-captioned matter. By the terms of the Board's Order, Respondent's license was suspended for six months with the possibility that the suspension be stayed at intervals. It further provided that Dr. Fisher participate in an education program administered by the Marquette School of Dentistry. The Order also provided that upon a showing by Respondent of complete, successful, and continuous compliance with the conditions of the order that he would be entitled to a return of his full license.

On September 5, 2001, the Board considered Michael C. Fisher's request that the limitations on his license be terminated. Based upon that request and upon evidence of Dr. Fisher's full compliance with the terms and conditions on his license,

NOW, THEREFORE, IT IS HEREBY ORDERED that all the limitations on the license of Michael C. Fisher to practice as a dentist in Wisconsin are lifted and he is restored to full licensure.
