The State of Wisconsin Department of Regulation and Licensing, having considered the record in the above captioned matter, makes the following Findings of Fact, Conclusions of Law and Order.

## FINDINGS OF FACT

1. Michael A Pharo (Applicant) whose address is 6400 Monona Drive, suite C, Madison, Wisconsin 53716 holds a limited Firearms Certifier Credential which was issued on July 3, 2001 by the State of Wisconsin Department of Regulation and Licensing (Department) under a Stipulation and Order for Issuance of a Limited Firearms Certifier Credential.
2. The Order Adopting Stipulation requires that Michael A. Pharo shall complete a 6-hour firearms instructor refresher course by September 1, 2001. A copy of the Order Adopting Stipulation is annexed hereto.
3. The Order Adopting Stipulation was extended to July 1, 2002 because the department was aware that a refresher course was not yet available. A copy of the Order Adopting Stipulation Extended is annexed hereto.
4. The Department has not received any evidence that Michael A. Pharo has completed the 6-hour firearms instructor refresher course by July 1, 2002.

## CONCLUSIONS OF LAW

- A. Under sec. 440.26(3m), Stats. and RL 34.34(2)(a)3, Wis. Admin. Code, an individual must provide evidence to the department that a 6-hour firearm instructor refresher course has been completed.

B. Applicant has not met the condition in the Order that requires successful completion of a 6-hour firearms instructor refresher course by July 1, 2002.

C. The Department has authority to issue the following Order under Chapter 440, Stats., and the provisions in the Stipulation and Order for Issuance of a Limited Firearms Certifier Credential.

## ORDER

Now, Therefore, It Is Ordered That the Limited Firearms Certifier Credential of Michael A. Pharo is REVOKED and Applicant Michael A. Pharo shall cease and desist from serving as a firearms certifier.

It Is Further Ordered That Applicant shall have an opportunity to challenge the accuracy of the information contained the FINDINGS OF FACT, above by submitting information to the Administrator, Division of Board Services, P.O. Box 8935, Madison WI 53708-8935 within 10 days after the date of signing, below.

It Is Further Ordered That Revocation of the Applicant's limited firearms certifier credential shall become effective on the tenth day after the date of signing, below.

It Is Further Ordered That Applicant shall immediately return the wallet size limited firearms certifier credential to the Department of Regulation and Licensing, Attention: Jan Bobholz, P.O. Box 8935, Madison, WI 53708-8935.
