On September 10, 2002, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Mark G. Anderson, R.Ph., for a modification of the board's *Final Decision and Order* ("*Order*") dated August 9, 2000, to allow him to work as a pharmacist in charge for an additional (8) eight hours per week for a total of (16) sixteen, and to be allowed to open and close the pharmacy.

Based upon the board's review,

IT IS HEREBY ORDERED that the petition of Mark G. Anderson, R.Ph., license number 9189, for modification of the *Order* is granted, and Mr. Anderson may work as a pharmacist-in-charge an additional (8) eight hours per week for a total of (16) sixteen hours per week, and may open or close the pharmacy, but not consecutively.
