On October 8, 2002, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Mark G. Anderson, R.Ph., for a three month stay of suspension and a modification of the board's *Final Decision and Order*, ("Order") dated August 9, 2000. The requested modification would reduce the individual and/or group therapy sessions required by paragraph 2 (b) (2) of the *Order*, currently set at one (1) time per month by order dated December 10, 2001, to one (1) time every eight weeks.

Based upon the board's review of the respondent's petition and the documents submitted therewith;

IT IS HEREBY ORDERED: that Mark G. Anderson, R.Ph., is granted a three-month stay of the suspension of license #9189 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED: The request to modify the individual and/or group therapy sessions required by paragraph 2 (b) (2) of the *Order*, currently set at one (1) time per month by order dated December 10, 2001, is DENIED.
