On September 10, 2002, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Thomas M. Triscari, R.Ph., for a three-month extension of the stay of suspension of his license to practice pharmacy in the State of Wisconsin, as provided within the board's *Final Decision and Order* ("Order") dated May 17, 2000, and a request to modify the required weekly individual/group therapy sessions as required by paragraph 2b(2) of the *Order* to once per month sessions. (By board order dated December, 2001, Triscari is currently required to attend two sessions per month.) Also requested was an increase of (12) twelve hours worked per week as a pharmacist in charge for a total of (24) twenty four hours. (By board order dated March, 2002, Triscari is currently allowed (12) twelve hours per week as a pharmacist in charge and may open and close the pharmacy.) Based upon the board's review,

IT IS HEREBY ORDERED that Thomas M. Triscari, R.Ph., is granted a three-month stay of the suspension of license #10029 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED that the request for modification of the required group therapy sessions to be reduced to once per month is GRANTED.

IT IS FURTHER ORDERED that the request for an increase in the number of hours worked as a pharmacist in charge is GRANTED for an additional (4) four hours per week for a total of (16) sixteen hours per week.
