On March 12, 2002, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Thomas M. Triscari, R.Ph., for a three-month extension of the stay of suspension of his license to practice pharmacy in the State of Wisconsin, as provided within the board's *Final Decision and Order* ("Order") dated May 17, 2000. Also requested was an increase in the hours worked as a pharmacist in charge, to be determined within the board's discretion. The respondent is currently practicing under a modification order dated December 11, 2001, allowing work as a pharmacist in charge for eight hours per week, with the ability to open and close the pharmacy. Based upon the board's review,

IT IS HEREBY ORDERED that Thomas M. Triscari, R.Ph., is granted a three-month stay of the suspension of license #10029 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED that the request for an increase in the number of hours worked as a pharmacist in charge is granted, to 12 hours per week.
