ORDER REINSTATING FULL LICENSURE

On May 26, 1999, applicant filed his application for a license to practice as a professional nurse in Wisconsin by endorsement from Minnesota. Subsequent to his application, applicant notified the board that he had been disciplined by the State of Minnesota Board of Nursing, and he submitted a copy of the Minnesota disciplinary Order. The board considered the matter at its meeting of September 17, 1999, at which time applicant appeared in support of his application. The board and applicant thereafter entered into a Stipulation by which the board agreed to issue and applicant agreed to accept a limited license to practice as a registered nurse in the State of Wisconsin.

By the terms of the board's Order Adopting the Stipulation, dated October 20, 1999, Mr. Liljequist was required to comply with all terms and conditions of the Stipulation and Consent Order issued by the Minnesota Board of Nursing dated June 3, 1999, and captioned "in the Matter of Kurt H. Liljequist, R.N." He was also responsible for submission to the Wisconsin Board of Nursing copies of the quarterly reports required under the Minnesota Order.

By the terms of the board's Order, upon removal of all limitations on applicant's Minnesota license by the Minnesota Board of nursing, applicant was permitted to apply to the Wisconsin board for a full unlimited license.

On December 5, 2002, the board considered Mr. Liljequist's request for termination of the limitations on his license. Based upon that request, and upon evidence that Mr. Liljequist's full license has been restored in Minnesota, it is ordered as follows:

<u>ORDER</u>

NOW THEREFORE, IT IS ORDERED that all limitations on the license of Kurt . Liljequist, RN, to practice as a professional nurse in Wisconsin are terminated, and Mr. Liljequist is hereby reinstated to full licensure.
