ORDER GRANTING STAY		

On August 2, 2001, the Board of Nursing entered its Final Decision and Order in the above-captioned matter. By the terms of the board's Order, Ms. Ashley's license to practice nursing was limited.. Limitations included the following:

- Ms. Ashley may practice only in settings where she works under supervision by another nurse or other licensed health care professional;
- Ms. Ashley must refrain from nursing employment as visiting nurse or other home care practitioner; and
- Ms. Ashley must refrain from working as a nurse on the night shift.
- For a period of at least one [1] year from the date of the Order, Ms. Ashley must arrange for quarterly reports from her nursing employer(s) reporting the terms and conditions of her employment and evaluating her work performance.
- Ms. Ashley must notify the Department Monitor of any change of employment during the time in which the Order is in effect. Notification must occur within fifteen (15) days of a change of employment and shall include an explanation of the reasons for the change.

On October 4, 2002, the board considered Ms. Ashley's request for reinstatement to full licensure. Based upon all information of record herein, the board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that all limitations on the license of Patricia B.

Ashley to practice as a licensed practical nurse in Wisconsin are terminated, and Ms. Ashley is hereby reinstated to full licensure.
