The respondent is subject to a Final Decision and Order dated October 10, 2001, ("*Order*"). Based upon previous review of the department's records maintained on behalf of the board, the respondent was found to have failed to comply with that portion of the *Order* which provided in part: "IT IS FURTHER ORDERED, that respondent's license is LIMITED in the following respect: respondent shall not be a managing pharmacist until he has taken and passed the patient consultation portion of the examination given to license applicants. Respondent shall take and pass the examination no later than 6/31/02. Respondent may not attempt the examination more than twice without permission of the Board. If respondent has not passed the examination by 6/31/02, respondent's license shall be SUSPENDED by staff without further action of the Board, until he has passed the examination." Thereupon, on July 1, 2002, the license of Jan R. Veenendaal, number 8435, to practice pharmacy in the State of Wisconsin, was SUSPENDED. The records of the department evidence that on October 7, 2002, Veenendaal successfully completed and passed the patient consultation examination as required by the *Order*.

THEREFORE, IT IS HEREBY ORDERED: that the SUSPENSION on the license of Jan R. Veenendaal, number 8435, to practice pharmacy in the State of Wisconsin, is REMOVED.
