On October 25, 2001, the Social Workers Section issued a Final Decision and Order reprimanding the respondent, Joanne R. Suckow, and requiring her to "take and complete a day long course or courses on the subject of anger management, which course(s) shall first be approved by the Section or its designee". The order required Ms. Suckow to complete the course(s) within 120 days of the date of the order, i.e. by February 22, 2002.

On January 3, 2002, Ms. Suckow wrote to the Section requesting an extension of time in which to complete the required course(s), due to medical reasons. On March 14, 2002, the Section granted the request and extended the time period for six months. Therefore,

IT IS ORDERED that paragraph 2 of the Order issued in this matter on October 25, 2001 be replaced by the following:

2. Respondent shall, by August 22, 2002, take and complete a day long course or courses on the subject of anger management, which course(s) shall first be approved by the Section or its designee. Respondent shall, within 30 days of completion of such course or courses, provide evidence of compliance with this paragraph to the Department Monitor.

All other provisions of the October 25, 2001 Final Decision and Order remain in effect.
